MINUTES OF REGULAR MEETING, NOVEMBER 5, 2018

1. CALL TO ORDER: The meeting was called to order at 7:00 PM by Chairperson Angell. Present were Committee members Botta, Cardwell, Valentini and Wais. Committee members Gomez and Melero were absent.
2. AGENDA ORDER: No requests for items out of order.
3. PUBLIC COMMENTS ON NON-AGENDA ITEMS: The Crockett Signal is now available. Compliments to the Sheriff who passed out candy at Halloween on Duperu. Reminder that on November 11 there will be a ceremony at Memorial Hall celebrating the 100th anniversary or the WW1 armistice. On December 1 the Women's Club is sponsoring a Tinsel Town event at the Old Homestead.
- 4.a. REPORT FROM DEPUTY: The Sheriff is still working at clearing vehicles/house trailer from the Nantucket area. Deputy Spangler reported that the drone flying around Duperu is not breaking any laws, and that there are really no laws regarding drones at this time. The drone owner is in compliance, a very nice gentleman. The public should be reminded he is following all guidelines/restrictions. The deputy has been working with the middle school on sexual harassment education.

- 4.c. NEIGHBORHOOD WATCH: No report.
- 4.d. TRUCK AND TRAFFIC UPDATES: L. Dombrowski is no longer in this position. C & H has this responsibility at their corporate offices. Reminder to contact them directly on any issues.
- 4.e. PUBLIC DISCUSSION: Discussion was held about the crosswalk by the Baptist Church. Mr. McDonald will investigate possible restrictions near crosswalk with the county. Possible red zones around crosswalk.

The sidewalk near Judy's Place is permanently closed.

High school students crossing against traffic lights and not staying within the crosswalks at 2nd and Pomona during lunch hour was discussed. Mr. Angell will advise John Swett principal, Jeff Wallace.
5. APPOINT MEMBER TO CONSOLIDATE PARKING SURVEY: The parking surveys are due by November 15. To date, we have received about 175-200 replies and the mailer was sent out to about 1800 homes. It is normal to get about a 10% response rate. Ms. Cardwell volunteered to work with Susan compiling survey stats.
