MINUTES OF REGULAR MEETING, SEPTEMBER 9, 2019

1. CALL TO ORDER: The meeting was called to order at 7:02 PM by Chairperson Angell. Present were Committee members Botta, Cardwell, Currington, Melero, Valentini and Wais.

2. AGENDA ORDER: No requests for items out of order.

3. PUBLIC COMMENTS ON NON-AGENDA ITEMS:

4.a. REPORT FROM DEPUTY: Deputy Spangler reported that over the Labor Day holiday the Sheriff's office had staged visible police cars at the Dead Fish intersection resulting in no sideshow. She reported that in East Contra Costa County there have been several sideshows. Auto Burglaries at the Dead Fish dropped off over the summer, but during the last three weeks there have been several broken car windows with nothing stolen. Deputy Spangler is still working on the vehicles near the gate on San Pablo Avenue. Vehicles have been towed however the motor home/trailers require heavy equipment to remove and this has been an obstacle. She also reported that the Sheriff's Department had a booth at the Sugartown Festival and was well-received. They gave out brochures and there was a good presence of officers. Discussion was held about abandoned cars around town. Procedures were discussed on calling these into the non-emergency number. Discussion was held about the noise downtown at night. Crockett has a no noise ordinance. The situation is not getting any better. The public was advised to contact the Board of Supervisors.

4.b. REPORT FROM CHP ON TRAFFIC ISSUES: Officer Wilkenfeld reported there have been sideshows on the Cummings Skyway. CHP trapped in the vehicles at both ends, ticketing participants. He reported he is aware of parking issues in Crockett and continues to warn offenders before ticketing. Officer Wilkenfeld had to leave the meeting due to an incident on Cummings Skyway.
